Local Control and Accountability Plan and Annual Update

The Local Control and Accountability Plan (LCAP) and annual update template shall be used to provide details regarding local educational agencies' (LEAs) actions and expenditures to support pupil outcomes and overall performance pursuant to Education Code sections 52060, 52066, 47605, 47605.5, and 47606.5.

For school districts, pursuant to Education Code section 52060, the LCAP must describe, for the school district and each school within the district, goals and specific actions to achieve those goals for all pupils and each subgroup of pupils identified in Education Code section 52052, including pupils with disabilities, for each of the state priorities and any locally identified priorities.

Charter schools, pursuant to Education Code sections 47605, 47605.5, and 47606.5, must describe goals and specific actions to achieve those goals for all pupils and each subgroup of pupils identified in Education Code section 52052, including pupils with disabilities, for each of the state priorities as applicable and any locally identified priorities. Course access: pupil enrollment in a broad course of study that includes all of the subject areas described in Education Code section 51210 and subdivisions (a) to (i), inclusive, of Section 51220, as applicable. (Priority 7)

Expelled pupils (for county offices of education only): coordination of instruction of expelled pupils pursuant to Education Code section 48926. (Priority 9)

Foster youth (for county offices of education only): coordination of services, including working with the county child welfare agency to share information, responding to the needs of the juvenile court system, and ensuring transfer of health and education records. (Priority 10)

B. Pupil Outcomes:

Pupil achievement: performance on standardized tests, score on Academic Performance Index, share of pupils that are college and career ready, share of English learners that become English proficient, English learner reclassification rate, share of pupils that pass Advanced Placement exams with 3 or higher, share of pupils determined prepared for college by the Early Assessment Program.

Other pupil outcomes: pupil outcomes in the subject areas described in Education Code section 51210 and subdivisions (a) to (i), inclusive, of Education Code section 51220, as applicable. (Priority 8)

C. Engagement:

Parent involvement: efforts to seek parent input in decision making, promotion of parent participation in programs for unduplicated pupils and special need subgroups. (Priority 3)

Pupil engagement: school attendance rates, chronic absenteeism rates, middle school dropout rates, high school dropout rates, high school graduations rates. (Priority 5)

School climate: pupil suspension rates, pupil expulsion rates, other local measures including surveys of pupils, parents and teachers on the sense of safety and school connectedness. (Priority 6)

Section 1: Stakeholder Engagement

Involvement Process	Impact on LCAP
<p>Open-door policy for formal and informal conversations among parents, teachers, students, and other stakeholders. Since the school is so small, this kind of communication is very effective and reaches the majority of stakeholders. Letters are sent home with students and mailed directly to keep parents informed and invite them to participate in decision-making. Invitations were mailed home and sent home with students inviting parents to attend a public hearing to view the draft LCAP and to solicit additional comments and input before the final draft is complete. On May 20, 2014 a public meeting was held where all parents and stake holders were invited to discuss and provide additional input into the LCAP.</p>	<p>All areas of the school are impacted by the needs and concerns of parents, students, teachers, and stakeholders. All ideas are heard and considered and to the extent that such input is sound and clearly in the best interests of student achievement, they are implemented. All input is given serious consideration before final decisions are made. Parent input resulted in the completion of a fitness and play area to benefit all students at the school last year. Due to parent and stakeholder concerns, the curriculum is being completely changed to address Common Core directly and student engagement has become the most important component of classroom instruction. Parent and stakeholder concerns have lead to the deletion of packet type classes from the schedule in favor of a direct instruction model. Clearly, stakeholder input has a profound impact on how this school operates in every aspect of the charter.</p>

80.92% of YCCS students are EL, low income, or foster youth, compared to the local district which is 70.10%. This should provide specified funds in the amount of \$130,095. These funds will be expended on increased and enhanced services to these students and their families in the form of dedicated clerical services, counseling services, Direct ELD instruction, and tutoring and support services specifically for EL, low income, and foster youth. These added and enhanced services will be available to all qualifying students K-12 at Yuba City Charter.

In the past year, no credentialed counselor was available. This year a counselor will be hired with a stipulation that at least 70% of counseling services rendered must be specifically for EL, low income and foster youth. Previously no ELD teacher was available. A credentialed ELD teacher will be hired to serve the EL population both in direct ELD instruction and additional support and tutoring services primarily for EL students but also extending to low income and foster youth students. Services to unduplicated students must and will be increased by 28.05% in 2014-15. This will be accomplished by providing a para-educator, a credentialed counselor, and administrative and clerical support either entirely or proportionally for the benefit of EL, low income and foster youth students.
