The Yuba City Unified School District has a long-established foundational principle of meaningful stakeholder engagement. These efforts were refined and improved through the Local Control and Accountability Plan (LCAP) development process. The District's practices have been further enhanced during the pandemic as the District sought the input and feedback of its stakeholder on its Distance Learning Model beginning in the early spring of 2020 and continuing through the development of the Local Continuity and Attendance Plan, the Expanded Learning Opportunities grant, the 2021-2022 LCAP, and now the ESSER III Plan. Combined school and District-level efforts have been conducted including virtual listening sessions with stakeholder groups and surveys that have generated valuable perspectives and information from student, parent, community partner and staff respondents. There were specific efforts taken to ensure important constituencies were heard representing students with special needs, English learners, foster youth, Title school populations, and students/families of low income. Throughout the past 18 months of the pandemic conditions, all stakeholder feedback was used to monitor existing programs and services as well as guide future planning efforts. Alignment of priority interests and needs has been continuously analyzed. All plans informed the development of subsequent plans. To obtain input on the optimal use of ESSER III funds a survey was developed and made available to students, staff, parents and the community. Survey details are noted below. The survey was structured with four open ended prompts. To efficiently summarize the comments and develop emergent themes, the district utilized a systemized process

then reviewed the groupings of comments and described the groupings in terms of a theme. A comprehensive information and communication strategy was implemented to inform stakeholders of the purpose of the ESSER funds, the value of their continued input, and how to access the survey. Multiple modalities were used at the District and school levels including email, text messaging as well as the school and District websites.

Specifically, the district participated in a community forum on September 7, 2021 with representatives advocating for children with disabilities, low income, foster youth, and homeless students were represented. Additionally the district held family and employee Q & A sessions. Based on the stakeholders in our community, we did not meet specifically with tribes or civil rights groups.

As is noted in the previous section, expansive stakeholder engagement efforts resulted in input and feedback into the District's planning and decision-making processes. Attention was paid to respondents feedback from each of the representative subpopulations of the overall community. This input and feedback were used to guide decision making. The information below denotes the priority themes that resulted from the ESSER III Plan surveys. Stakeholder influence on the ESSER Plan is evidenced by the direct alignment of the District's actions with the needs and interests identified by students, parents, staff, and community partners.

- Water dispensers on campus to refill bottles of water
- Clean restrooms with soap and sanitizer stations
- Sanitation between classes
- Anti Bullying instruction, particularly at middle school
- Field trips (Additional)
- Incentives to hire bus drivers, more drivers, more transportation options
- Shade structures
- Cameras in the classroom so kids at home can still access teaching when they are in quarantine
- Healthier meals that kids want to eat, reduce lines in cafeteria so kids have time to eat
- Improve ventilation and air purification in schools
- Para educators need a livable wage
- Substitute incentives, such as bonuses, or extra pay to encourage teachers to sub on their prep.
- Behavior supports for students
- Summer learning and afterschool programs
- Mental health services and supports
- Summer enrichment program
- In-person tutoring, pay paras and others to tutor
- Smaller class sizes for students.

- Educational technology to go home with students
- Improve school facilities
- More instructional aides
- Additional intervention teachers at each site
- More one-on-one support for students
- More competitive salary schedule for teachers
- More SPED teachers to reduce caseloads

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
